FRUIT EXPORT AND MARKETING ACT 1906

Fruit Export and Marketing (Amendment) Regulations 2021

In exercise of the powers conferred on me by section 9 of the Fruit Export and Marketing Act 1906, I hereby make these Regulations—

Short title and commencement

- 1.—(1) These Regulations may be cited as the Fruit Export and Marketing (Amendment) Regulations 2021.
 - (2) These Regulations come into force on 1 August 2021.
- (3) In these Regulations, the Fruit Export and Marketing Regulations 1931 is referred to as the "Principal Regulations".

Regulation 4 amended

2. Regulation 4(1A) of the Principal Regulations is amended after "\$5" by inserting "(VEP) and must be paid into the account of the Biosecurity Authority of Fiji".

Schedule 8 amended

3. Schedule 8 to the Principal Regulations is amended by deleting "Permanent Secretary" and substituting—

"Chief Executive Officer Biosecurity Authority of Fiji".
