

## COVID-19 Update Office Closure

Given the evolving situation concerning COVID-19, PwC Fiji is taking considered action to protect the health, safety and wellbeing of our people, contractors, clients, visitors, suppliers and the wider community.

In line with the Fiji Government's following announcements and despite the lockdown in Lautoka lifted this morning, to ensure the safety of our people, clients and stakeholders, both our offices in Suva and Lautoka will be closed until further notice:

- Lockdown in Suva for 14 days from 3 April 2020 (except for certain essential services); and
- Nationwide curfew from 8pm to 5am every day until further notice.

During this time most of our teams will be working from home. Working flexibly is already a key part of how we operate and our PwC team is well equipped to work outside our office environment. Our IT systems are designed to suit a remote workforce including virtual meeting and technology solutions designed to help us work effectively with each other and our clients across multiple locations.

Other measures we have put in place include:

- Reminding our people that if they are unwell, they should not be working.
- Reminding everyone at PwC Fiji about the Fiji Ministry of Health and World Health Organisation guidelines on illness prevention and good hygiene measures.
- Mobilising our internal business continuity and incident response team. PwC Fiji has in place a Business Continuity Management System including incident response plans and protocols to prepare for, respond to, and recover from various types of operational threats. Our business continuity plans are intended to protect our people and reduce the level of potential service interruption to our clients.
