Lodgment due dates extended

The Fiji Revenue and Customs Service (“FRCS”) has extended the due dates for the lodgment of certain tax return types under the New Tax Information System (also known as the Taxpayer Online Services Portal or TPOS) as follows:

Return	Extended due date
<ul style="list-style-type: none">November 2019 returns	29 February 2020
<ul style="list-style-type: none">December 2019 returnsQuarter 4 2019 returnsYearly returns for 2019	31 March 2020

The FRCS has advised that while the lodgment dates have been extended, the **due dates for payments remain unchanged**.

We understand that the FRCS requires that these returns be submitted via the TPOS.

If you are experiencing any issues with the TPOS or require assistance, please feel free to contact the FRCS. Alternatively, we would be glad to appropriately assist.

PUBLIC NOTICE

LODGEMENT DATES EXTENDED

The Fiji Revenue and Customs Services (FRCS) wishes to advise members of the Public that the lodgement dates for all tax types which is in the New Tax Information System (NTIS) has been further extended as follows;

- 1) November 2019 filing due date now falls on 29th February 2020
- 2) December 2019, Fourth quarter return 2019 and yearly return 2019, due date now falls on 31st March 2020.

All customers are encouraged to submit their returns online however if you are unable to do so, our officers are ready to assist you.

Whilst the lodgement dates have been extended, the payment dates remain the same.
