## Re-registration of Companies, Foreign Companies and Business Names

Under the Fiji Companies Act, re-registration is required for all companies, foreign companies and business names unless the company, foreign company, or a business name was registered under the Fiji Companies Act 2015 on or after 14 June 2019.

The end date for the re-registration of companies, foreign companies and business names has been extended as follows:

Foreign Company	15 January 2020	15 July 2020	31 December 2020
Business Name	15 January 2020	15 October 2020	31 December 2020
